Bonus Sale Regulations "Stones of Souls"

§ 1. GENERAL PROVISIONS

- 1. These regulations define the rules of participation in the Bonus Sale Program "Stones of Souls".
- 2. The organizer of the Bonus Sale is Monetico Sp. z o.o., NIP: 8992938356.
- 3. Bonus Sale are directed only to natural persons who meet certain criteria indicated in § 4 of these Regulations.
- 4. Bonus Sale do not constitute any of the games referred to in art. 2 of the Act of November 19, 2009 on Gambling Games (ie, OJ from 2018, item 165, as amended), in particular it is not related to conducting any lottery or drawing.
- 5. Regulations contain conditions for participation in Bonus Sale.

§ 2. DEFINITIONS

The following terms used in the Regulations have the meaning defined below:

- 1. Regulations mean these Regulations of Bonus Sale.
- 2. Bonus Selling Organizer Monetico Sp. z o.o., with a registered office in Wrocław.
- 3. Bonus Sale action carried out by Monetico Sp. z o.o., the purpose of which is to promote purchase of products and services offered by the Bonus Sale organizer.
- 4. User it should be understood as a natural person registered in the Portal and using to the full extent services provided within the domain www.gamehag.com.
- 5. Games Games available at gamehag.com
- 6. Bonus Sale participant a natural person not conducting business activity final recipient of services and goods of the organizer who received Stones of Souls during Bonus Sale.
- 7. Stones of Souls points awarded free or payable to the Participant, collected on the Participant's Account. The User obtains Stones of Souls free of charge in return for completing tasks while using the Games placed on the Portal and switching to the next level of experience in the Games used.

§ 3. DURATION OF BONUS SALE

Bonus Sale lasts from 01.02.2019 to 31.12.2023, with the option of extending the Bonus Sale by Organizer.

§ 4. PRINCIPLES OF PROMOTION

The Bonus Sale Participant can be a natural person who, after commencement of Bonus Sale, will purchase from the Organizer in exchange for completing tasks when using Games placed on the Portal and switching to the next Level of experience in the Games used, the appropriate amount of Stones of Souls.

- 1. The Bonus Sale Participant takes part in it personally, and the rights are not transferable to another person.
- 2. In the promotion can not participate:
 - a. employees of the Company that is the Bonus Sale Organizer,
 - b. other people related to the preparation and conducting of this promotion,

- c. spouses, descendants, parents, siblings of persons mentioned in points a-b.
- 3. Participation in Bonus Sale is voluntary and free.

§ 5. PRIZES

- 1. Rewards in Bonus Sale:
 - a. Depending on the number of Stones of Souls collected, various rewards are foreseen. The participant will receive a prize for 1 grosz, which for a given amount of Stones of Souls, currently will be in the Organizer's offer.
- 2. The number of games to be granted during the Bonus Sale is limited.

§ 6. COMPLAINTS AND CLAIMS

- 1. Complaints regarding Bonus Sale should be reported to the Organizer and will be considered within 14 days from the date of receipt to the Organizer.
- 2. Complaints should include name, surname and exact address of the Participant, as well as a description and indication of reasons for complaint.
- 3. The Participant of Bonus Sale will be informed about the outcome of complaint by e-mail or in writing to the address provided by Bonus Sale Participant on the date specified in paragraph
- 4. Disputes arising from these Regulations shall be resolved by common courts.
- 5. Participants entitled to receive the Prize can not demand replacement of the prize for other products or exchange of the Prize for monetary equivalent.

§ 7. PROTECTION OF PERSONAL DATA

- 1. The administrator of personal data of Participants is Monetico Sp. z o.o. with headquarters at ul. Hubska 52 lok. 14, 50-502 Wrocław.
- 2. Participants' personal data is collected and processed in order to implement the Promotion.
- 3. The data controller entrusts personal data of Participants for processing in connection with the implementation of Promotion.
- 4. Participants have the right to access their data and to correct them.
- 5. Providing personal data is completely voluntary, but necessary to participate in the Promotion.
- 6. The data will be processed in accordance with the provisions of the Act on the Protection of Personal Data and the privacy policy available on the Website.
- 7. Personal data provided is confidential and will not be disclosed to third parties, unless such disclosure is necessary due to generally applicable law.

§ 8. FINAL PROVISIONS

- Before taking part in the Bonus Sale, the Participant should read Regulations.
 Taking part in Bonus Sale is considered in case of doubts as reading Regulations and accepting them.
- 2. In matters not covered by these Regulations, provisions of the Civil Code shall apply.
- 3. Regulations are available at the Organizer's registered office.
- 4. Taking part in the promotion means participant's consent to all conditions of promotion defined in these Regulations,

5. Bonus Sale Regulations and promotion shall enter into force on 1.02.2019.
